#### WELCOME - REGULAR SESSION / PLEDGE OF ALLEGIANCE / ROLL CALL

Chair Joan Starkel called the meeting to order @6:55pm following the JCESD Budget Committee Meeting. Board Secretary noted board member attendance.

Chair Joan Starkel called for a motion to approve the agenda.

#### **AGENDA ADOPTION**

Dani Cowdrey made the motion to approve the agenda as presented, motion was seconded by Daniel Petke; motion passed unanimously – **Approved 5/0** (1-absent).

#### **Steve Rankin Memorial Grants**

✓ 2023-2024 Posting & Process Update

Superintendent Shay Mikalson presented on the Steve Rankin Memorial Grant process, explaining that the application process was posted on the JCESD website and shared with the component districts, with a deadline of May 19, 2023.

Superintendent Shay Mikalson introduced Delaney Sharp from Black Butte School to present on one of the projects that was awarded a Steve Rankin Memorial Grant from last year.

✓ Black Butte Bat Boxes – previous year's Steve Rankin memorial awards

Delaney Sharp joined the meeting remotely, introduced himself, welcomed people to come and see the Black Butte School. He shared that the Black Butte School has applied for Steve Rankin Grants for years – this one, was awarded last year, which allowed them to provide all the materials and he presented a PowerPoint presentation about the Black Butte Bat Boxes.

Board members asked questions about the bat boxes (where the bats access; how the bats roost and the capacity of the boxes) and discussion took place. Delaney explained the process and said he will keep the board updated if they have any bats move in!

#### **Teacher of the Year – Next Steps**

Superintendent Shay Mikalson explained the Teacher of the Year process and shared that the Jefferson County ESD region has three applicants this year. He explained that he will be asking for one or two board members to join the executive team as a blue ribbon panel to make a decision by the end of May; regional teachers of the year will be honored across the state in September 2023 and one of
